Review of the Order of St Asaph

Background

The Order of St Asaph was approved by the Standing Committee in November 2012 as a way of recognising and honouring the outstanding contribution of lay people across the diocese. The award specifically recognises outstanding service to the diocese, rather than service at a more local level. The Advisory Panel of the Order of St Asaph would like to widen the criteria for the award so that outstanding service at a more local level can also be recognised with this award. This might include service to a church, a school or a Mission Area, for example. This proposal has the support of the Bishop of St Asaph.
